Understanding Your Risk: I understand that I and/or my child/dependent/ward are voluntarily participants in the activities offered by AZ Air Time, LLC including but not limited to the use of the equipment, facilities and the premises. I am assuming on behalf of myself and all stated child/dependent/ward listed below, all risk of personal injury, death, or disability to myself and/or my child/dependent/ward that may result from participation, or any damage, loss or theft of any personal property which myself and/or my child/dependent/ward may incur. I understand that the AZ Air Time, LLC facility has trampolines and inflatables and that using this equipment has inherent risks. I have explained this risk to every person listed in my party below. In spite of the risk explained to me I and/or my child/dependent/ward want to participate at the facility and I and/or my child/dependent/ward assume all of the responsibility for injury or death that may occur.

Understanding Your Liability: I understand that I or my child/dependent/ward will be engaging in a recreational and sporting activity at AZ Air Time, LLC. I or my child/dependent/ward understand participation is voluntary and is an informed decision to release any future lawsuits or claims that I, my child/dependent/ward may have against the release of liability waiver. Therefore I agree on behalf of myself, child/dependent/ward and any representative, successors, heirs, and assigns to hold AZ Air Time, LLC and its affiliates, instructor's, officers, directors, agents, employees, designers, licensors, and members, as well as the property owner and tenants of the property harmless for any and all claims or causes of action arising out of me and my child/dependent/ward participation at AZ Air Time, LLC facilities and/or activities.

Understanding "Hold Harmless": To the extent permitted by law, I and/or my child/dependent/ward agree to defend, indemnify and hold harmless AZ Air Time, LLC its/their officers, directors, agents and employees from and against any/all claims, suits, liens, judgments, damages, losses and expense including reasonable legal fees and costs arising in whole or in part and in any manner from my experience at AZ Air Time, LLC. By signing this agreement I understand that I and/or my child/dependent/ward hold harmless AZ Air Time, LLC for the activities that I am paying to participate in at AZ Air Time, LLC. This also includes any/all contractors including but not limited to trampoline manufacturers, location building owners, any and all contractors hired by AZ Air Time, LLC.

Understanding Security: I hereby grant unto AZ Air Time, LLC permission to use my or my child/dependent/ward, photograph and/or videotaped image, face, likeness, voice and appearance while engaging in the purposes mentioned above at AZ Air Time, LLC. I understand and agree that AZ Air Time, LLC may use these photos and/or videotaped images in subsequent facilities, promotional publicity and indefinitely unless I revoke this authorization by notification in writing. I further grant unto permission to permit my child and/or ward to be photographed, audio/videotaped, or interviewed by the news media or other organizations for any activity related stories or articles. AZ Air Time, LLC reserves the right to monitor any and all activity for the safety and security of our jumpers. If necessary, these materials will be released to the proper authorities to prosecute any/all inappropriate behavior.

Full Release and Waiver of Liability: The undersigned voluntarily make and grant this Waiver of Liability, Hold Harmless Agreement, and Understanding of Risk in partial consideration (in addition to monies paid to AZ Air Time, LLC) for the opportunity to use the facilities, equipment, materials and/or to receive assistance in training, safety, and instruction from the personnel of AZ Air Time, LLC. I do hereby waive and release any and all claims whether in contract or of personal injury, bodily injury, property damage, damages, losses and/or death that may arise from the aforementioned use or receipt, as I understand and recognize that there are certain risks, dangers, and perils connected with such use. I hereby acknowledge after inquiry and investigation of event, duration, and completeness that my risk has been explained to me and I fully understand, assume and accept that risk. I further acknowledge that the explanation written in this waiver is wholly satisfactory and acceptable to me.

I further agree to use my best judgment in undertaking these activities, and to fully adhere to all safety instructions and recommendations, whether oral or written. I hereby certify that I am a competent adult assuming these risks of my own free will, being under no compulsion or duress. **I also acknowledge that I read and speak English.**
